RESOLUTION TO DIRECT STAFF TO AMEND THE TOWN OF DUMFRIES TAXICAB ORDINANCE AND TO AUTHORIZE THE TOWN MANAGER TO ENTER INTO A JOINT TAXICAB SERVICE AGREEMENT BETWEEN THE TOWN OF DUMFRIES AND PRINCE WILLIAM COUNTY

WHEREAS, the Town of Dumfries (Dumfries) taxicab ordinance was adopted more than twenty years ago and is out of date and requires updating to conform to current transportation and safety concerns; and

WHEREAS, once Dumfries amends its Taxicab Ordinance to conform to Prince William County's, the Parties will have adopted substantially similar ordinances (the "Ordinances") for the regulation of taxicabs within their jurisdiction; and

WHEREAS, Dumfries Town Council and the Board of Supervisors of Prince William County, Virginia (hereinafter the Parties) recognize the necessity of uniform taxicab regulations across jurisdictional boundaries to ensure public safety and provide a more efficient means of enforcing such regulations; and

WHEREAS, the Parties recognize that a joint jurisdictional effort will improve the regional transportation system.

NOW, THEREFORE BE IT RESOLVED by the Dumfries Town Council on this 17th day of April that staff is directed to amend the Town's taxicab ordinance to conform to Prince William County's and thereafter Council authorizes the Mayor and the Town Manager to enter into a joint service taxicab service agreement with the Board of Supervisors of Prince William County.
