## Neighborhood and Business Community Liaisons

The Town of Dumfries has been divided into five areas for the purpose of assigning Police Officers who will serve as a Neighborhood and Business Community Liaison for each designated area. A Police Officer will also be assigned to each established Home Owners Association as well. The purpose of the Neighborhood and Business Community Liaison Officer is to serve as the primary contact for citizens and business owners who are located within a specified area to contact when they have general questions, concerns, or issues that are related to law enforcement.

If a citizen or business owner is not certain in which area their home or business is located, they should contact the Dumfries Police Department at (703) 221-1111 to speak with someone for assistance.

Citizens and business owners/representatives should contact 9-1-1 in cases where there is an emergency; and dispatch at (703) 792-6500 to file a report.

### Districts/Liaisons

#### Route 234 and Route 1 Area/Grayson Village, Tripoli Heights

This includes all residents and businesses on Route 234 from the Town line to Route 1; those businesses on the east side of Route 1 to the north Town line; and both sides of Route 1 from Route 234 to Old Stage Coach Road.

This area includes Tripoli Heights and Grayson Village.
