PROCLAMATION DECLARING NATIONAL GUN VIOLENCE SURVIVORS WEEK FEBRUARY 1 – 7, 2023

This proclamation declares the week of February 1, 2023, to February 7, 2023, to be National Gun Violence Survivor Week in the Town of Dumfries, Virginia to honor and remember all victims and survivors of gun violence and uplift the resilient voices of survivors across the nation.

WHEREAS, every year, nearly 40,000 Americans are killed in acts of gun violence and approximately 76,000 more are shot and wounded;

WHEREAS, every year, on average, 1,605 Virginia residents are killed in acts of gun violence and nearly 1,911 more are shot and wounded;

WHEREAS, by early February, more Americans are killed with guns than are killed in our peer countries in an entire calendar year;

WHEREAS, a gun violence survivor is anyone who has personally experienced gun violence — whether you have witnessed an act of gun violence, been threatened or wounded with a gun, or had someone you know and cared for wounded or killed;

WHEREAS, forms of gun violence can include, but are not limited to: gun suicides, gun homicides, domestic violence involving a gun, shootings by law enforcement, and unintentional shootings;

WHEREAS, 59 percent of American adults, including 71 percent of Black and Latinx Americans, or someone they care for has experienced gun violence in their lifetime, demonstrating the reach and impact gun violence has in communities across America;

WHEREAS, firearms are the leading cause of death for children and teens;

WHEREAS, people in America in cities across the nation are working to end the senseless violence by advocating for commonsense gun safety legislation;

WHEREAS, by commemorating National Gun Violence Survivors Week on February 1 to February 7, cities across America will raise awareness about gun violence and honor the lives stolen by gun violence; and

WHEREAS, we renew our commitment to reduce gun violence and pledge to do all we can to keep firearms out of the hands of those who are a danger to themselves or others and encourage responsible gun ownership to help keep our communities safe.

NOW, THEREFORE BE IT RESOLVED, that the **TOWN COUNCIL OF DUMFRIES**, **VIRGINIA**, do hereby proclaim February 1 to February 7, 2023 to be **NATIONAL GUN VIOLENCE SURVIVORS WEEK** and encourage all citizens to support their communities' efforts to prevent the tragic effects of gun violence and to honor and value human lives.

PROCLAMATION RECOGNIZING BLACK HISTORY MONTH

WHEREAS, the month of February is nationally recognized as Black History Month; and

WHEREAS, during this time, we celebrate the many achievements and contributions made by African Americans to our economic, cultural, spiritual, and political development; and

WHEREAS, for generations, the story of American progress has been shaped by the inextinguishable belief that change is always possible and a brighter future lies ahead; and

WHEREAS, we celebrate giants of the civil rights movement and countless other men and women whose names are etched on the cornerstones of our country; and

WHEREAS, in 1915 Dr. Carter Godwin Woodson, noted scholar, Harvard University trained historian, and son of former slaves, founded the Association for the Study of African American Life and History, with the intent of raising awareness for African American's contributions to civilization; and

WHEREAS, Dr. Woodson initiated Black History Week, beginning February 12, 1926; and, for many years following, Black History Week was celebrated during the second week of February; and

WHEREAS, in 1976, as part of the United States of America's bicentennial, Black History Week was expanded and established as Black History Month. In that year President Gerald R. Ford urged Americans to "seize the opportunity to honor the too-often neglected accomplishments of black Americans in every area of endeavor throughout our history"; and

WHEREAS, we understand that more than 400 years ago, the first enslaved Africans in Englishoccupied North America were brought to Virginia; and

WHEREAS, despite constant adversity throughout American history, African American culture and heritage is continually strengthened, each generation; and

WHEREAS, the national theme for Black History Month 2023 is "Black Resistance"; and

WHEREAS, African Americans have resisted historic and ongoing oppression, in all forms, especially the racial terrorism of lynching, racial pogroms, and police killings, since the nation's earliest days; and

WHEREAS, the complexity of the Black family offers a rich tapestry of images for exploring the African American past, present, and future.

NOW, THEREFORE, BE IT PROCLAIMED BY THE TOWN COUNCIL OF DUMFRIES, VIRGINIA, do hereby proclaim February 2023 as **BLACK HISTORY MONTH** in the Town of Dumfries, Virginia and call this observance to the attention of our citizens.


About DVS

DVS Benefits Division

- DVS Veteran Service Representatives are accredited with the U.S. Department of Veterans Affairs to submit claims and appeals to the U.S. Department of Veterans Affairs
- We electronically submit all VA claims, appeals and supporting documents to the appropriate VA Regional Office, as well as tracking those claims by logging into the Veterans Benefits Administration (VBA) systems

Disability Compensation Benefits

- Purpose
 - VA Disability Compensation Benefits is designed to compensate a veteran for diminished work capacity as a result of a disability incurred in military service
- Eligibility
 - Must be a Veteran
 - Active Duty military service with a DD-214
 - Injury incurred during active/inactive duty for training for Reserve and National Guard
- Requirements
 - Service Connected Disability Claims
 - Disability compensation is a benefit for current disabilities that are related to an inservice injury, illness, or hazardous exposure.
 - Disability compensation can open doors to additional benefits, such as healthcare.
 - No time limits to file a claim after service
