What are Specialty Programs?

- Specialty Programs are PWCS programs that focus on:
 - career exploration,
 - subject area concentration, and
 - college/university preparation.
- All elementary and middle school programs are interest-based, transport programs
- Most high school programs are interest-based programs.
- Transfer, Transport, and Site-Based opportunities are available.





Types of Specialty Programs

Transfer

Students participating in these programs will transfer to the program location for all courses and activities

All ES and MS programs and most HS programs

Transport

Students participating in these programs attend all core classes, non-CTE classes, and activities at their base school

Some HS programs

Site-based

Program is located only at the base school

HS JROTC programs

Available Transportation

Traditional Bus Service

Stops within the neighborhood school boundaries and provides access to the neighborhood school.

Express Bus Service

Stops outside the neighborhood school boundaries and provides access to the Specialty Program school.

*Specialty Program students attending a program outside of their zoned school may use an express bus stop. The family indicates the preferred stop on the application.





Activities and Athletics

- Governed by the Virginia High School League (VHSL).
- Eligibility is established in 9th grade.
- Students applying for a specialty program in 10th or 11th grade may request a special waiver.
- After establishing eligibility, students may be ineligible for up to 365 days if a program or school change is made.
